- Expanded Foreword by Dr Jörg Reinbothe, the architect of the Directive.

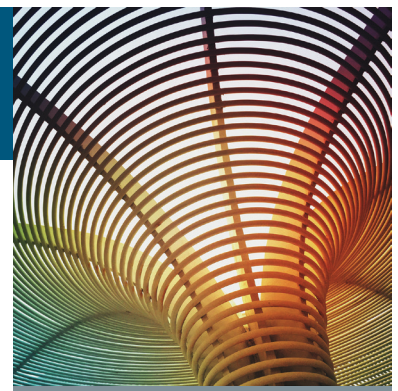
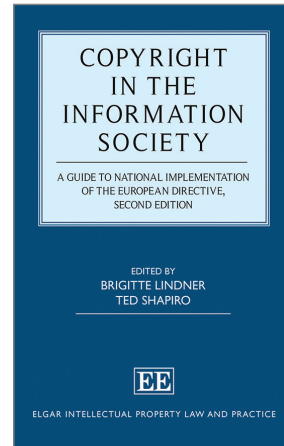
