- inform the contractor of the outcome of the assessment; and
- put in place a compliant dispute resolution process.

Compliance with these rules is necessary to manage the following risks:

1. Employment tax liability:

Your business could be liable for unpaid employment taxes (plus penalties and interest) should HMRC successfully challenge an incorrect self-employed status determination.

2. Damaged relations and risk of disputes:

Inconsistent or incorrect application of the rules may damage contractor relations and increase the likelihood of work force disputes or HMRC challenge.

3. Corporate criminal offence:

Incorrectly engaging contractors as self-employed could also prompt penalty fines and be a criminal offence for which the directors of your business may be accountable under separate tax legislation.
